Key deposits are refundable for up to seven (7) days after termination of service and only on return of the original key in good condition.

8) Postage due and C.O.D. mail and parcels will be accepted only if applicant has made an appropriate deposit in advance with MBP.

2) MBP upon placing applicant's mail in the assigned box shall be deemed to have delivered mail and shall not be liable for loss or theft.

9) Applicant understands that this is not a rental agreement that place MBP and the applicant in a landlord/tenant position, but rather it is an agreement of bailment.

3) Upon termination of services, MBP shall not be responsible for holding applicant's mail and shall thereafter dispose of it in accordance with postal regulations

10) Possession of a lock box key is considered by MBP to be valid evidence that possessor is authorized to remove mail from boxes.

4) Applicant agrees to use MBP services in a lawful manner and in compliance with all Federal, Provincial and Municipal statutes and regulations.
